EUSD utilized a similar approach to stakeholder engagement for ESSER III as articulated in the LCAP 21-24 document, as well as the Learning Continuity and Attendance Plan (see links above). In engaging our stakeholders for LCAP, LCP, and ESSER III, we utilized the following avenues:

- 1. **Leadership Team** Meetings with site and district leadership were used to determine the needs of students as aligned to ESSER III goals.
- 2. **EUTA/EUCO Leadership** Our bargaining units (certificated and classified staff) were consulted during meetings for input for all plans (ESSER, LCP, LCAP).
- 3. **Parent and Student Surveys** EUSD conducted numerous surveys for parents and students for the development of the LCAP and LCP. The results of these surveys have been utilized in the development of this plan.
- 4. PTC Officers Meeting EUSD conducts monthly meetings with PTC officers from all seven (7) sites.

- 5. **EL Parents Meeting** The district conducted an EL parent night last May of 2021 and feedback we have received from parents is utilized in the drafting of this plan.
- 6. **Feedback from Parent as Educator Workshops** EUSD conducts a parent workshop addressing different topics and feedback is secured via informal questions at the end of each question.
- 7. Curriculum and Instruction Meetings/Job-Alike Meetings For academic year 2020-21, EUSD conducted 3 C and I meetings for each core subject area where questions/feedback were solicited for the development of the LCAP and the LCP. Bi-weekly meetings with Intervention Teachers (EL Support Teachers) were also utilized to seek feedback on how to support EL and SED students' needs. Along with these meetings, job-alike meetings with counselors, SpEd teachers, and nurses, were held and input solicited. These input and feedback have been utilized to develop this ESSER III Plan.

### A description of how the development of the plan was influenced by community input.

Parents, students, teachers and leadership have indicated input that allowed EUSD to analyze and synthesize common themes and also articulate priorities for the development of this report. Leadership also met to ensure that other different COVID-associated funding sources are aligned to district goals within the landscape of COVID and do not duplicate efforts incorporated into this ESSER III Plan. EUSD utilizes both qualitative and quantitative data in developing its plans, including ESSER. Qualitative data consists of informal classroom observation and interview data, albeit these opportunities were significantly limited by COVID mitigation protocols.

# Addressing the Impact of Lost Instructional Time

A description of how the LEA will use funds to address the academic impact of lost instructional time.

## Total ESSER III funds being used to address the academic impact of lost instructional time

This will be used to fund summer school for 3 years for Grades 1 to 7, covering the costs of 7 teachers and 1 administrator (1 summer school = Approximately \$30,000).

EUSD's 2021 CAASPP scores indicate that unfinished learning did contribute to a significant decrease in performance, for ELA, Math and Science. Proficiency rates in ELA dropped by 6% whereas Math proficiency rates decreased by 8%. The same achievement gaps persisted for 2021. Performance by sites varied and followed the same trend seen in longitudinal data: sites with higher numbers of ELs (English Learners), SWDs (Students with Disabilities), and SEDs (Socio-Economically Disadvantaged) manifested more significant decreases in proficiency rates.

# **ESSER III Expenditure Plan Instructions**

#### Introduction

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities
  Act, upon request; and
- Be made publicly available on the LEA's website.

- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students'
    academic progress and assist educators in meeting students' academic needs, including through differentiated
    instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including
    in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

 School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;

- continuous and safe in-person learning and/or to addressing the impact of lost instructional time, the LEA may indicate that it is not implementing additional actions.
- Specify the amount of ESSER III funds the LEA plans to expend to implement the action(s); these ESSER III funds must be in addition to any funding for those action(s) already included in the plan(s) referenced by the LEA. # **Ensuring Interventions are Addressing Student Needs**
